**“Red Hare Brewing Company Spring Training Giveaway” Official Rules**

*NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.*

1. **Eligibility:** The Giveaway is open to the members of the general public who are residents of Georgia, are at least 21 years old as of the date of entry, and possess a valid Georgia driver’s license.
