“Jimmy John’s Business Delivery Giveaway” Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. **Eligibility:** The Giveaway is open to the members of the general public who are residents of Georgia and at least 21 years old as of the date of entry. Employees, directors, officers, and agents of Dickey Broadcasting Company, d/b/a WCNN-AM, Jimmy John’s Franchise, LLC (“Jimmy John’s”) (WCNN-AM and Jimmy John’s collectively referred to as "Sponsor"), and their respective affiliates and the immediate families and household members of such persons are not eligible.
2. Void where prohibited by law. By entering this Giveaway, you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

One (1) Grand Prize winner will be randomly selected from all eligible entries on the last Thursday of each month during the Promotional Period and will be notified via phone and/or email. There will be a total of eleven (11) Grand Prize winners (one per month) during the Promotional Period.
