

**WNNK-FM/WINK 104 “50 Shades Darker”
Contest
Official Contest Rules**

A complete copy of these rules can be obtained at the offices of radio station **WNNK-FM/WINK 104**, owned and operated by Cumulus Broadcasting LLC (collectively, the “Station”), 2300 Vartan Way, Harrisburg, PA 17110, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the “50 Shades Darker” contest (the “Contest”) substantially as described in these rules on the following Station website: www.wink104.com and by participating, each participant agrees as follows:

1. No purchase is necessary. Void where prohibited. All federal, state, and local regulations apply.
2. Only legal U.S. residents age 18 or older (or other designated age restrictions deemed by station) with a valid Social Security number at the time of entry and currently live in the and currently reside in Dauphin, Cumberland, Lebanon, Perry, York or Lancaster counties in Pennsylvania are eligible to participate in STATIONS CONTEST. Employees, agents, representatives, or affiliates of the Station, its affiliates, participating sponsors, other radio stations, television stations and print advertising companies serving the metro area, and their immediate family members and household members are not eligible to participate. The term “immediate family members” includes spouses, parents, siblings, grandparents, children, grandchildren and cohabiting significant others.

We’ll ask for a certain caller number and if they’re the correct Caller they’ll win a pair of tickets 3) We’ll be doing special Ticket Stops at various locations throughout Central PA. We’ll have a certain amount of tickets available for a certain period of time. The first (amount to be determined) people to be at the location first will get a Free Pair of tickets. Station is not responsible for lost, stolen, mutilated, destroyed, misdelivered, postage due, illegible, incomplete or untimely entries. Entrants may be disqualified at the sole discretion of the station. Failure to respond to Cumulus Media once winner has been contacted that they have won within 24 hours will result in another winner being chosen.

All prizes must be redeemed within 30 days of the contest end date unless otherwise specified. If a winner cannot be contacted or is disqualified, the Company reserves the right to determine an alternate winner or not to award that winner’s prize, in its sole discretion. The Company is not acting as the manufacturer or distributor of any prize awarded. The Company makes no warranties with respect to any prize. With respect to any claims for cancelled, postponed, or rained out concert, sporting event or show ticket prizes, winner should look to the provider or others in the chain of production and distribution but excluding the Station and the Company. 13. By participating in the Contest, each participant agrees to receive email communications from the Station regarding Station events and contests. Any participant that opts-out of these mailings will also remove themselves from the contest.
14. By participating in the Contest, participants agree to be bound by the decisions of Station personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the administration or outcome as the Station deems appropriate. All decisions will be made by the Station are final. The Station may waive any of these rules in its sole discretion.
